EXECUTIVE ORDER NO. 3 Series of 2021

AN EXECUTIVE ORDER EXTENDING THE IMPLEMENTATION OF THE MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) IN THE PROVINCE OF BULACAN FROM 01 UNTIL 28 FEBRUARY 2021

WHEREAS, on 08 March 2020, President Rodrigo Roa Duterte issued *Proclamation No. 922* declaring a State of Public Health Emergency throughout the Philippines and enjoined all local government units (LGUs) to render full assistance and cooperation to implement urgent and critical measures to contain or prevent the spread of Covid-19, mitigate its effects and impact to the community, and prevent serious disruption of the functioning of the government and the community;

WHEREAS, on 16 March 2020, President Duterte issued *Proclamation No. 929* declaring a State of Calamity throughout the Philippines and placed the entire Island of Luzon under Enhanced Community Quarantine (ECQ);

WHEREAS, the undersigned issued *Executive Order No. 36, series of 2020*, implementing the Modified General Community Quarantine (MGCQ) in the Province of Bulacan from 01 until 30 November 2020;

WHEREAS, the Province of Bulacan has been placed under different quarantine classifications and, on 29 January 2021, the Inter-Agency Task Force on Emerging and Infectious Diseases (IATF) extended the Modified General Community Quarantine (MGCQ) over the province from 01 February 2021 until 28 February 2021;

WHEREAS, pursuant to Section 465, Par. (b) of the Local Government Code, the Provincial Governor, as the chief executive of the provincial government, is authorized to adopt such emergency measures as may be necessary during and in the aftermath of man-made and natural disasters and calamities, issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances, and ensure that the acts of all LGUs in the province and their officials are within the scope of their prescribed powers, duties, and functions.

NOW, THEREFORE, I, DANIEL R. FERNANDO, Provincial Governor of Bulacan, by virtue of the powers vested in me by law, do hereby order that the effectivity of *Executive Order No. 36, Series of 2020*, which implemented the MGCQ in the entire province shall be extended until midnight of 28 February 2021, unless sooner modified or terminated by subsequent executive orders or issuances by competent authority.
